RESOLUTION DETERMINING TO PROCEED TO LEVY A TAX IN EXCESS OF THE TEN-MILL LIMITATION

WHEREAS, pursuant to the provisions of Section 5705.21 of the Ohio Revised Code, this Board has, by resolution adopted April 3, 2025, determined the necessity to levy a renewal tax in excess of such ten-mill limitation for the purpose of permanent improvements at the rate not exceeding seven-tenths of one (0.7) mill for each one dollar (\$1.00) of valuation, which amounts to seven cents (\$0.07) for each one hundred dollars (\$100.00) of valuation, for a continuing period of time. Said general permanent improvement tax is proposed to renew an existing seven-tenths of one (0.7) mill, five (5) year levy in its entirety for the purpose of permanent improvements authorized by a majority the electors of the School District voting on said proposition at an election held on November 3, 2020; and

WHEREAS, the Van Wert County Auditor has certified the School District's assessed valuation and the tax revenue to be produced annually by the proposed renewal levy.

BE IT RESOLVED by the Board of Education of the Vantage Career Center Joint Vocational School District (herein the "School District"), Counties of Allen, Auglaize, Mercer, Paulding, Putnam and Van Wert, Ohio, two-thirds of all the members elected thereto concurring:

SECTION 1. That the Board of Education hereby determines to proceed with the levy and the question of the adoption of said renewal tax shall be submitted to the electors of the entire territory of the School District at the election to be held on November 4, 2025, and if said renewal tax is approved by a majority of said electors such renewal tax levy shall first be placed upon the 2026 tax list and duplicate, for first collection in calendar year 2027.

SECTION 2. That the form of the ballot to be used at said election shall be substantially as follows:

A renewal of a tax for the benefit of the Vantage Career Center Joint Vocational School District for the purpose of permanent improvements, that the County Auditor estimates will collect \$795,129 annually, at a rate not exceeding .7 mills for each \$1 of taxable value, which amounts to \$8.48 for each \$100,000 of the County Auditor's appraised value, for a continuing period of time.

That it is found and determined that all formal actions of this Board of Education concerning and relating to the adoption of this resolution were adopted in an open meeting of this Board of Education; and that all deliberations of this Board of Education and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with the law, including Section 121.22 of the Ohio Revised Code.
