Submit Program Application \$30 A \$30 non-refundable application fee is required.

Schedule Pre-entrance Exam \$100 Pass the required pre-entrance exam, HESI.

Background Check (BCI/FBI) \$70

Pre-entrance is to be completed at Vantage Career Center. The office is open Monday through Thursday from 8:30 a.m. to 6 p.m. and Friday from 8:30 a.m. to 3 p.m.

Pre NCLEX-testing. OBN requires an additional BCI/FBI check before taking the licensure exam. This fee is included in the NCLEX licensure expenses. You can complete it at the Vantage Career Center. The office is open Monday through Thursday from 8:30 a.m. to 6 p.m. and Friday from 8:30 a.m. to 3 p.m.

☐ Immunizations (Heath Requirement)* Must be completed before acceptance. ☐ Students who can provide documentation of being previously vaccinated, demonstrating immunization or an acceptable titer level do not need to repeat the vaccine.
Program Acceptance The faculty committee will review the application for acceptance once all admission criteria have been completed and submitted.
Tuition Deposit \$200 Once you receive an acceptance letter by mail a \$200 deposit (applied towards your tuition) is required to accept your place in the program.
Financial Assistance Complete your 2024-2025 FAFSA online at www.fafsa.gov . Our federal school code is 030956. Tuition assistance may be available through your employer, Ohio Means Jobs from the county where you live, or VA Educational Benefits—Veterans can apply for their benefits through the financial aid office.
