- Automated Telephone Request – Call 1-800-908-9946 and follow prompts to receive your 2021 Tax Return Transcript. Transcript is generally received within 10 business days.
- Paper Request Form - IRS Form 4506T-EZ or IRS Form 4506-T Transcript is generally received within 10 business days from the IRS's receipt of the paper request form.
